FORMS AND WEAPONS COMPETITION

Judges will award from 5 point to 10 points with half points being allowed based on beauty, grace, rhythm, power and technique. The lowest and highest scores will be dropped.

Competitors:

- 1. Announce your name.
- 2. Announce your school name.

SPARRING COMPETITION MANDATORY EQUIPTMENT

- 1. No Face, Head, Neck, or Groin contact permitted for All belts.
- 2. Black Belts ONLY LIGHT CONTACT with foot techniques is allowed to protected sides of the head.
- 3. Chest Protectors and Headgear, Hand Arm pads, Foot pads and Mouthpieces, Groin Cup are required.
- 4. Color belts...... Two, 60 second rounds with a 30 second break.
- 5. Black Belt Children...... Two, 1 minute 30 second rounds with a 30 second break.
- 6. Black Belt Adults (15 years and above)...... Two, 2 minute rounds with a 30 second break.

BREAKING COMPETITION

All competitors must supply their own breaking materials to be inspected prior to demonstration.

You can purchase boards at the tournament. All competitors will be grouped in an appropriate foursome.

<u> Rank</u>		Breaking Technique
\	0	4 0 - - - - - - -

White – Orange 1 or 3 boards: any kick, and hand techniques

Green – Blue 2 or 4 boards: any kick, and hand techniques

Brown – Red: 3 or 5 boards: any kick, and hand techniques

1st - 4nd Dan any combination of kicking and /or hand techniques

GENERAL RULE COMMENTS

- 1. Only one coach permitted in the ring for each competitor.
- 2. All divisions will be strictly by rank, gender and age.
- 3. No Divisions may be combined without the tournament director's consent.
- 4. If a Division has only one competitor, they will be declared the winner.
- 5. Rules will be fair and strictly enforced (KAMDF and WTF)
- 6. Lack of discipline by competitors, coaches or cheering parties will disqualify the competitor from the match.
- 7. NO REFUNDS will be made. No personal checks accepted after early registration date.
- 8. Divisions will be categorized by primary belt color. (Tip color will not be taken into consideration).
- 9. Mandatory: Official Ko Am Mu Do Federation uniform
